Sir,

I the undersigned would like to report that, vide SP-CCP Order No. Mentioned above, a combine team comprising of District Police, Churachandpur, Forest Department /CCPur, 129 CRPF, 1st IRB CCPUR and Executive Magistrate /CCPur launched a destruction of illegal poppy cultivation in Thinghangjang Hill Range, Under Churachandpur Sub-Division from 10:00Am- 01-:00 Pm. Total area of illegal poppy cultivation distructed was estimated to be 20 acres approximately. During the operation, no arrest was made and the cultivators are not known. However burned down two hut used by the unknown cultivators and 5 (five) pieces of poppy plants with pods have been seized in the presence of witnesses at about 10: 00 Am at the spot.

The illegal Poppy cultivation destroyed to be worth Rs. 1,25,00,000 (One Crore Twenty Five Lakhs) approximately in international market.

I the undersigned would like to report that, vide SP-CCP Order No. Mentioned above, a combine team comprising of District Police, Churachandpur, Forest Department /CCPur, 129 CRPF, 1<sup>st</sup> IRB CCPUR and Executive Magistrate /CCPur launched a destruction of illegal poppy cultivation in Thinghangjang Hill Range, Under Churachandpur Sub-Division from 10:00Am- 01-:00 Pm.
