Subject: Report.

Sir,

Today i.e the 17th January, 2026 @ 9:35AM received a reliable input that one unknown person . will be transporting illegal drugs consignment in one Maruti Gypsy from, Behiang side along Teddim Road. Immediately, Executive Magistrate, Singngat Sub-Division was requisitioned for magisterial witness and OC/BHG-PS was also informed and requested to send one team so as to trap the said vehicle. Self along with OC and escort team left Singngat-PS to intercept the Vehicle.

At around 10:40AM the team set up a Temporary Motor Vehicle Check Post near Likhai Village and waited. At around 11:15AM one Maruti Gypsy coming from Behiang side was stopped, followed by Behiang-PS team led by SI Shominthang Kipgen. The vehicle was thoroughly searched but no incriminating article was found inside the vehicle. However, as per source input the consignment is concealed in a secret compartment built inside the fuel tank. As, such, the vehicle was taken to Singngat-PS for ascertaining the contents of the fuel tank. When the fuel tank was taken down, a hidden compartment was discovered. The secret compartment was opened in the presence of the Executive Magistrate and some items suspected to be Raw Opium were found neatly wrapped in plastic/polythene.

The suspected raw Opium were weigh using a weighing scale and found to weigh 16.583 Kgs. The suspected raw Opium and the vehicle were then seized in the presence of the Executive Magistrate and witnesses by preparing a proper Seizure Memo. And, the driver of the vehicle namely Mr. Nang Lian Siam (35) s/o (L) Tuanzamuam of ZMA Road, Vengnuam, New Lamka, Churachandpur was also arrested for possession and transportation of the seized items i.e suspected raw Opium.

The arrested accused person and the seized suspected raw Opium along with the vehicle (One white Maruti Gypsy) were handed over to you for taking further necessary legal action.

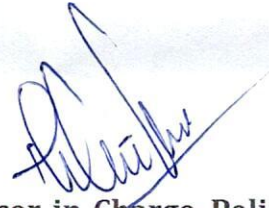
