
11. First Information contents:



Today, i.e. 20-02-2026, a combined team comprising of Churachandpur District Police, Forest Department, 129 CRPF, 1st IRB Ccpur, NAB Ccpur, and Executive Magistrate/Henglep, under the supervision of Shri Ravi Gangwar, IPS (Probation), launched a destruction drive of illegal poppy cultivation at Mongken area under Henglep PS jurisdiction, Churachandpur.

Destruction operation started at 10:00 am and concluded at 1:00 pm, and during the operation, a total area of 20 acres were destroyed. The total value of destructed poppy cultivation is estimated to be worth Rs. 1,00,00,000/-. However, during the operation, no arrest was made as no cultivators were found and the land owner could not be identified as it is located in the interior region. However, 10 pods of poppy plants were seized from the area of destruction by observing formality.

Hence, a suo-moto case under FIR No. 02(02)2026 HLP-PS U/S 18/29 ND&PS Act, has been registered for investigation.
