I am to state that on 22/02/2026 at about 2:30 pm a combined team of District Police Chandel, under the strict supervision of SP/Chandel and Commandant of 43 AR led by Shri Ts. Chamna Anal, MPS. Addl SP(OPs)-CDL, with the team of i/c OC Chakpikarong Police Station and Col. of Ex 43 AR led by Asst. Commandant Ravinder Kumar. A joint operation was launched in the Gen Area in between T Bollok and L. Molhoi village, Chakpikarong Sub-Division, Chandel District, and further corroboration by own source. The area was cordoned and searched for presence of any contraband, weapon and War like Stores (WLS). During thorough searched, a hidden cache were found at 5:45 pm to include (1) one (01) G-3, No. Y-100111 with empty magazine, (2) 3 (three) Lethod Guns (country made), (3) Two (02) Single-barrel guns, (4) Three (03) bomb Shells (Locally made), (5) Four (04) Pompi, (6) Two (02) Carbine with empty Mag.(Locally made), (7) Two (02) Mag. Pouch, (8) Fifty five (55) 7.62 mm Live ammunition of AK Rifle., (9) Eight (08) Baofang Radio Sets and (10) One(01) Dagger with cover were found. The above arms mentioned/recovered arms and ammunition are being handed over to Chakpikarong Police Station:-
