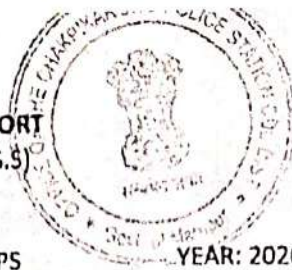

## FIRST INFORMATION REPORT

1. Int : As per input received from District Police, Chandel and corroborated by own sources about movement of anti-social elements from CCpur towards Moreh.
2. Ops – on the same day 10/3/2026 At 00640 hrs, a suspected Eco Van with 01 male and 02 females was intercepted by PVCP of COB Salluk. After detailed checking of the vehicle and belongings it was found that these individuals were going from CCpur to Moreh via CCpur-Salluk- Beru Khudam – Moreh Rd and were in possession of 58 x soap cases of Brown Sugar and ₹45200 cash. Accordingly the suspected 58 numbers of soap cases of Brown Sugar and other items as noted below were seized from their respective possession.
3. On detailed questioning of the individuals, it was found that they are namely Thaongminthang (34 yrs), Nengboi Haokip (48 yrs) and Ch Nemneikim mate. (47 yrs)
4. Details of Individuals Apprehended.
  1. Thaongminthang (male) vill: Moreh ward No-2, Tengnoupal District. Age-34 yrs.
  2. Nengboi Haokip (female) vill: Khonomphai, Tengnoupal District. Age – 48 yrs.
  3. Ch Nemneikim Mate (female) Vill: Khonomphai, Tengnoupal District. Age - 47 yrs.
