Respected Sir,

I, Md. Belal, being duly authorized representative of Pace Digitek Limited, a company incorporated and registered under the Companies Act, 1956, having its Circle office at BUBUPARA, hereby file this complaint on behalf of the Company and wish to inform you that we have a mobile tower installed at Khubung Khunou, P.O- , District : Chandel, (SITE I.D. UVN2MNP00749 / Site Name: Khubung Khunou).

On the evening of 16th March, 2026, 12:2 pm, when I visited our mobile tower site, I discovered that 1 (One) Lithium Ion Battery amounting to Rs. 93000/- (Rupees Ninety Three Thousand only), had been stolen from the site. The theft appears to have been committed by unknown persons, which has caused a financial loss to our company and disrupted network connectivity in the area.

In view of the above circumstances, we respectfully request you to kindly intervene in the matter, conduct a detailed inquiry, apprehend the culprits, and ensure that they are punished in accordance with the law, in the interest of justice. We assure you of our full support and cooperation during the course of the investigation
