Sir,

It is respectfully submitted that on 07/03/2026 at about 7:00 PM, an incident occurred at Nongpok Sekmai NESAs (North Eastern Sporting Association) ground while organizing the Yaoshang Thabal Chongba festival organized by the local club and Meira Paibis of our locality. While the programme was about to start, one individual namely Sinam Robert @ Robot Meitei (40) S/o. S. Nimai Meitei of Nongpok Sekmai Makha Leikai came to the said place holding an iron rod and started threatening and attempt to murder the President of the NESAs club namely Wangjam Tomba Singh (35) years S/o (L) W. Shamu Singh of Nongpok Sekmai Mayai Leikai along with other members of the club and volunteers present at the spot. Seeing his violent act, the members of the club tried to stop him and snatched the iron rod from Sinam Robert. In the meantime one Ngairangbam Ratan Singh aged about (41) years S/o Ng. Biramani Singh of Nongpok Sekmai Makha Leikai came to place and arranged/managed to escape Sinam Robert from the spot. Accordingly, Sinam Robert escaped from the spot by taking the advantages of darkness. It is mentioned that Ngairangbam Ratan also commit the crime in collision with Sinam Robert.

It is therefore, the iron rod used by Sinam Robert and Ngairangbam Ratan is hereby handed over to you and requested to kindly take necessary legal action against them as per law on behalf of the NESAs club.
