Today i.e the 19th March, 2026 at around 07:30 pm received information that some unknown arm miscreants numbering about 5 (Five) men came in one blue colour car registration number not known and parked nearby road at Ravalon village and at @ 7:00pm The arm miscreant forcibly broke into the house of Sumpi Ngamhring (65) s/o (L) SP. Thumtung of Ravalon village, Chakpikarong Sub-Division, Chandel District and assaulted him using small arms (Pistol). Later the unknown arm miscreants kidnapped his wife Timkhochin Haokip (48) by firing some rounds before fleeing towards Salluk village. Hence, a regular case under FIR No. 07(03)2026 CKG-PS u/s 118, 140,331, 3(5) BNS & 27 A.Act. has been registered on Suo-Motto for investigation of the case.
