

Sir,

With due regards, I beg to state that today on 20/03/2026 at about 07:10 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Leirongthel Pitra Maning Ching for using offensive act against State Security Forces and CAPF.

On receipt of the information, joint team of Commando Unit, Thoubal led by Insp. K. Nitaranjan Singh, OC/CDO Thoubal under the command of Shri. H. Devendra Singh, Addl. SP(Ops), Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police Thoubal and columns of 165 TA and 7 Madras Regiment have rushed to the spot immediately and launched a massive operation at 07:30 a.m. On searching and found the undernoted articles from the spot and seized at 08:18 a.m. by observing formalities.
