Sir,

With due regards, I beg to state that today on 20/03/2026 at about 6:50 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Haokhong Ching for using offensive act against State Security Forces and CAPF.

On receipt of the information, joint team of Commando Unit, Thoubal under the command of Shri. H. Devendra Singh, Addl. SP(Ops), Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police Thoubal and columns of 16 and 31 Assam Rifles have rushed to the spot immediately and launched a massive operation at 7:50 a.m. On searching and found the undernoted articles from the spot and seized at 08:20 a.m. by observing formalities.

Details of seized articles :-

1. 2(two) nos. of Pistol with magazine i.e. i) B/regn No. 2772 & ii) mark as MADE IN VIETNAM, B/regn. No. 22.
2. 5(five) nos. of Bore Action Single Barrel Rifle i.e. Bearing Body Nos. HY3309, JH2020, KU2206, LH5002, LB6800.
3. 4(four) nos. of HE Mortar Shell

The massive searched Operation was conducted from 7:50 am to 08: 50.a.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
