Immediately, Shri Lianminthang Samte SDC/CCPur was deputed for Magisterial Duty by Deputy Commissioner, Churachandpur. A Strong Police team comprising Addl/SP(Ops)/CCPur, WPS-CCP, CCP-PS and along with the Executive Magistrate rushed at the said house and conducted house search in presence of the Executive Magistrate. During the search 05 (Five) transparent plastic Package were found containing 11 (Eleven) soap cases each (Total 5x11=55 soap cases) suspected to be contraband brown sugar drugs in one wooden Bed Box located at their Common room.
