Subject: URGENT: Formal Complaint regarding armed ambush, criminal intimidation, and direct threat to life at Mongkot Chepu Village.

Madam,

I am writing to formally report a grave security incident and a direct attempt on the safety of my family and staff that occurred today, April 6, 2026.

Incident Overview:

- **Time:** Approximately 4:00 PM.
- **Location:** NH-202, roadside houses within Mangkot Chepu Village.
- **Convoy Members:** Myself (DC Ukhrul), DFO Ukhrul, and DRDA staff.
- **Family Present:** My mother, wife, and two children (including an infant).
- **Escort:** BSF personnel in Casper vehicles.

Account of the Incident: While our convoy was in transit from Imphal to Ukhrul, a group of armed individuals emerged from residential houses along the highway at Mangkot Chepu and forcibly blocked our passage. The situation escalated dangerously when the individuals loaded their firearms and deliberately pointed them at the vehicle containing my mother, wife, and children. Despite the presence of the BSF escort and their attempts to communicate, the armed group surrounded my family's vehicle, maintaining their weapons in a firing position pointed at the occupants. They issued verbal threats, stating, "We don't want any DC, go back," and refused to clear the road.

The hostile environment and the direct targeting of my infant and family with lethal weapons necessitated an immediate retreat to prevent a loss of life.

Immediate Requirements: In light of this brazen act of terror and the targeting of a public servant's family, I request the following:

1. **Immediate Sanitization:** Launch an operation to clear and sanitize the NH-202 stretch at Mangkot Chepu to ensure safe passage.
2. **Criminal Prosecution:** Register an FIR for attempted murder, criminal intimidation, and using prohibited arms to obstruct a public servant.
3. **Area Search:** Identify and apprehend the individuals who emerged from the roadside houses.

4. **Security Reinforcement:** Deploy additional forces to secure the corridor between Imphal and Ukhrul to prevent further blockades of district administration.

The safety of the district administration has been compromised. I expect a prompt report on the actions taken.
