2. During the op, the coln cordoned the suspected area at Gen A Matijang and carried out a detailed search. One individual was detained, who identified himself as Lutjakai Vaiphei @ Maozy (Age – 20 yrs, DOB – 15 Oct 2006), S/o Lamkholun Vaiphei, R/o Leijang Khopi Village. On-spot verification and subsequent interrogation confirmed that he is an active and operational cadre of UKNA (Non Soo GP) holding Cadre No. 009.
