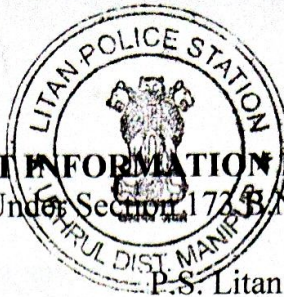

**SUB:FIR REGARDING BULLET INJURY CAUSING DEATH DURING
OPERATIONAL DUTY.**

Respected Sir,

It is respectfully submitted that on 10.04.2026, troops of A Coy, 170 Bn BSF (Adhoc M&C XVI Bn BSF under M&C XXII Bn BSF) were deployed on operational duty at Observation Point from 1200 hrs to 1800 hrs consisting of party 02 SOs and 02 ORs, Total – 04 persinMongkotChepu Bazar area.

2. On 10.04.2026 No. 170801463 CT(GD) Mithun Mandal of 'A' Coy (Ex -170 BnBSF) (Adhoc M&C XVI Bn BSF under M&C XXII Bn BSF) was performing duty at Observation point/ ROPof village MongkotChepubazar area under PS-Litan, Distt- Ukhrul, Manipur with the strength of 02 SOS and 02 ORS from 1200 hrs to 1800 hrs. During the day, intermittent cross firing was taking place between armed miscreants of Mongkot Chepu (Shangkai Hill) and Leingangching hill area. At about 1640 hrs, armed miscreants fired from Thoubalriver hill ridge side towards the said duty point of CT Mithun Mandal. In retaliation CT Mithun Mandal fired 03 Rds towards the direction of fire. In the meantime, he was shot at the back of his left shoulder at about 1645 hrs.

3. Due to the effective retaliation by BSF troops, firing from the armedmiscreants side stopped. Further on receipt of the information, the coy commander along with QRT party and Dr. Maninder Singh, AC/MO a/w Nursing assistant reached the location. First aid was administered on the spot under operational conditions and thereafter the injured constable was swiftly evacuated in ambulance to RIMS Hospital, Imphal by Insp/GD Kundan Mandal along with escort party for further medical treatment. At about 1735 hrs individual was admitted to RIMS hospital Imphal and on 10.04.2026 at about 1750 hrs however the treating doctor declared him brought dead.

4. In view of the above, it is requested that an FIR may kindly be lodged regarding the incident of cross firing by armed groups leading to death of BSF person, and necessary legal action may be initiated.

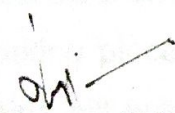
