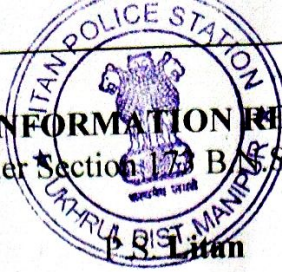

Brief of the case:

It is learned from sources that on 07-02-2026 at around 21:30 hrs there was a fight between some Tangkhul boys and some Kuki boys at Litan bazaar area near Forest Beat Office. In that one Tangkhul boy was beaten up by Kuki boys and got seriously injured on his bodies. However no complaint was made to this PS, they reportedly plan to settle among themselves on the next day. However, on 08-02-2026 at around 2:00 p.m. some youths from Sikibung came to chief residence of Litan Sareikhong demanding to hand over the culprits who were involved in the incident of 07-02-2026, as the culprits were not handed over the situation escalated leading to mobilisation of people from both side. Pelting stone against each other. 24 houses i.e. 18 houses belonging to Tangkhul community including 2 (two) government quarter occupied by the Tangkhul & one unoccupied government quarter was set on fire by unknown person suspected to be Kuki communities & 5 Houses belonging to Kuki communities including 1 (One) Govt. Quarter occupied by the Kuki communities was also set on fire by unknown person suspected to be Tangkhul communities at Litan Sareikhong. There was also an exchange of gun fire between the parties. In order to prevent the violence clash between the two parties as well as to safe the burning houses. A combine security forces rush to the said area as a last resort when all option were exhausted, the security force use minimum force such as firing tear gas and blank fire to disburse the violence mob, to prevent further escalation and violent conflict between the two parties. Two Police personnel got injuries in their body.
