Sir, With reference to the above cited subject, I have the honour to report to you as follows:

That, I, Mr. Thongsei Haokip (48) S/o (L) Semthang Haokip, is a permanent resident of S. Mualzawl Village, P.S. Churachandpur, Kangvai Sub-Division, Churachandpur District, Manipur.

That on the 3rd May, 2023, at around 4:30 pm a communal violence broke out in Manipur following which we had abandoned our house and locality and fled for our safety as our village is close to the Meitei settlement. So, in order to save our lives, we left our house with all our belongings and in the process unknown miscreants barged into our house and all our household properties were stolen away. The date of occurrence in which our properties were damaged and stolen was probably during the month of May 3rd, 2023 at around 5:00 PM

The total cost of the property damage estimated to be Rs. 11.5 Lakhs only.

I could not report the matter in time as I was of the opinion that CSO leaders of the Relief Camp would have filed FIR as the same was submitted to them but it came to my knowledge now that FIR has not been registered. Now, as FIR is made mandatory to avail welfare schemes for the IDPs, I am constraint to report the matter this late with the hope that my losses are compensated.

I, therefore, humbly request you to kindly register an FIR about my grievances so that my loss is compensated.

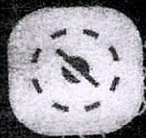
