Subject : Zero FIR- Report of looting and Damage to house and property on 8th August, 2023 during the Meitei-Kuki crisis.

Respected Sir,

I, Mrs. T. Tinneikim Haokip W/o. Paolun Haokip, originally from L. Semol Village, near Panjang and presently residing at Kingkin village, Churachandpur District, would like to file this Zero FIR to report an incident of looting and damage to my house and personal property that occurred on 8th August, 2023, during the Meitei – Kuki crisis.

On the said date, unknown miscreants forcibly entered my house, looted valuable items, and caused extensive damage to the house and other belonging. Due to the violence and unrest at that time, I was unable to protect my property, and the loss has severely affected me and my family.

Reason for delay in Reporting:

I could not file this report earlier because I was out of station for safety reasons, as the situation was extremely unsafe. Additionally, displacement, lack of communication, and difficulty in returning to my village made it impossible for me to approach the police in time. Therefore, the delay in filing this FIR is purely due to circumstances beyond my control.

I kindly request your good office to register this Zero FIR, investigate the matter, and take necessary action as per law. I shall provide any additional information or cooperation required during the investigation.

I also declared that all the information provided above is true to the best of my knowledge and belief.
