I have the honour to report that, today i.e 18<sup>th</sup> February 2026 at around 5 pm received a reliable inputs of movement of contraband items from Singnhat road towards Churachandpur town, a team of District Police, Churachandpur along with women police personnel were placed at Mata area for surveillance and interception unit from 6.10 pm but could not intercepted the suspect. Further, at around 7.00 pm on receiving the same inputs of the suspect's location at Koite area, the teams proceeded towards the area and intercepted the suspect's house at around 7.50 pm. The suspect's house was cordoned off for house search. So accordingly, a requisition is made for Executive Magistrate and civil witnesses for search of the house. Executive Magistrate namely Mrs. Kimkhanching, SDC/EM Tuibong, Churachandpur was deputed at the spot.
