Sir,

I have the honour to state that today i.e. 10th March, 2026 at about 5:00 PM, a joint team of Maram PS and 16 Assam Rifles conducting a random frisking and checking at Naojai about 3 km east of Maram PS. The joint teams intercepted one Gypsy without a registration number. On checking, a substance suspected to be opium was detected. As such DC/SPT was intimated by my senior officer and a request was made to depute one Magistrate. Accordingly, Shri. Panii James SDO/BDO Lairouching was deputed for doing the necessary procedures. In the presence of the Magistrate, the vehicle was thoroughly searched and approx. 10.63 kg worth Rs. 50,31,500 (Fifty lakhs thirty one thousand five hundred) of suspected opium was found concealed at the back of the front seat and right door of the Gypsy. The driver, Yaronso Ramsan (26) yrs s/o Joy Ramsan of Sirarakhong Village, Ukhrul District and co-passenger Shunreingam Khayi (37) yrs s/o Bijoy Khayi of Teinem Village, Ukhrul District were arrested in the presence of Magistrate after observing due formalities. Therefore, the arrested persons were handed over to OC/MRM-PS for taking legal action as per the law.


