Today i.e. 27/02/2026 at 11:30 AM received reliable information from source that some contraband drugs are keep concealed in the Grocery Shop of Thuamlianding at Kanaan Veng, YPA Road, New Lamka, Churachandpur. Submitted (convey) the information to the SP/CCPur and a requisition for deputing one Executive Magistrate was submitted to Deputy Commissioner, Churachandpur, to be present while conducting search u/s 50 ND&PS Act. Immediately, Shri Lianminthang Samte SDC/CCPur was deputed for Magisterial Duty by Deputy Commissioner, Churachandpur. A Police team comprising CCP-PS lead by SI Paul Lallminglien of CCP-PS and WPS-CCP, and along with the Executive Magistrate rushed at the Grocery shop of Thuamlianding and conducted house search in presence of the Executive Magistrate. During the search 05 (Five) Soap cases of suspected brown sugar marked as A1 to A5. Weighing A1= 11 grams, A2=12 grams, A3= 11grams, A4=13 Grams and A5= 10 Grams and total is 57 Grams. And another 5 (Five) numbers of suspected WY Packed and sealed marked as B1 to B5 Weighing

B1=1183 Grams packed and sealed inside one plastic packet marked "999"  
B2= 1182 Grams " " " " " " " " " " "999"  
B3=697 grams " " " " " " " " " " "999"  
B4=227 Grams " " " " " " " " " " "999"  
B5=223 Grams " " " " " " " " " " "999"

and total is roughly 3512 grams (including the weight of the plastic) are seized in presence of the Executive Magistrate at 12:50 PM at Grocery Shop (Kanaan Veng, New Lamka, CCPur) and arrested Mrs Thuamlianding 56 yrs w/o Pauchinkhup of Zion Veng, New Lamka, CCPur, at 12:55 PM. Further, as a follow up action, house search was also conducted at Thuamlianding (arrested) residents at Zion Veng, New Lamka, Churachandpur, and seized the following items (Narcotics Drugs) in presence of the Executive Magistrate at 1:30 PM i.e. 02 (Two) packets of suspected WY Packets marked as C1 and C2. Marked as C1=1194 Grams (Packed and seal inside one plastic packet marked "999") and C2= 642 Grams (Packed inside one Yellow plastic Packet). One Black colour Jupiter TVS B/Regd no. MN02G 9041. The seized contraband drugs suspected to be Brown sugar, WY Tablets and One Black colour Jupiter TVS B/Regd no. MN02G 9041 and the arrested accused person were handed over to Officer-in-Charge, Churachandpur Police Station for further legal necessary action.
