1. It is submitted that a letter issued by the Leingangching/Laho Litan Village Authority dated 21 April 2026, titled "Condemnation of Unauthorized Military Operations and Procedural Lapses by the 8th Bihar Regiment and Assam Rifles at Litan and its Vicinity Areas", contains false, baseless, and defamatory allegations against the Indian Army and Assam Rifles.
2. The said letter falsely accuses security forces of illegal actions, procedural lapses, and alleges collusion with militants, which is completely unfounded and without any factual basis. Such statements are highly misleading and appear intended to incite distrust and hostility among the local population.
3. It is further submitted that, based on this misinformation, a publication namely People's Chronicle has printed and circulated a news report propagating these false claims, thereby maligning the image of the Indian Army, which is deployed in the area solely to maintain peace, stability, and security.
4. The dissemination of such false and provocative information has the potential to disturb public order, create unnecessary panic, and adversely affect civil-military relations in this sensitive region.
5. In view of the above, it is requested that necessary legal action be initiated against the individuals and organizations responsible for issuing and circulating the said letter and spreading misinformation. It is also requested that the role of the concerned publication in amplifying unverified and false claims be examined.
