Received an information that on 22/03/2026 at around 03:00 pm, some unknown miscreants have started an agitation at in front of Kuki zo Council President Mr Henlianthang resident at Red cross road, CCpur. to show their discontent over some Kuki Zo Council member meeting with the Chief Minister of Manipur at Guwahati by setting up road blocks, obstructing the free flow of traffic. The mob grew larger in number and resorted to violence, pelting of stones towards the security personnel deployed for law and order duty. Additional security forces were deployed as a preventive measures and in order to disperse the unruly mob security personnel resorted to lathi charge to the unruly mob and fired several rounds of tear gas shell in the air. Due to the incident some security personnel who were deployed for law and order duty were injured. The situation was eventually brought to control. Again on the same day at around 06:00 PM some unknown miscreants started gathering at sielmat bridge and obstructed the free flow of traffic and public by setting up road blocks and burning of tyres the agitating mob pelted stones towards the security personnel deployed for law and order duty. At around 08:30 PM some unknown armed miscreants started firing somewhere from bijang village towards the security personnel deployed at Sielmat Bridge and central force deployed around the area responded accordingly, Due to the incident one RAF personnel was hit by a bullet on the elbow and immediately rush to the Hospital for medical treatment. Combing and search was conducted in the area but the unknown armed miscreants have fled taking advantage of the dark. Situation is tense in the periphery at the moment however, the situation is brought to control at around 03:00 am (23/03/2026) and unruly mob dispersed off peacefully using minimal force.
