Through sustained efforts to cultivate sources and establish an effective intelligence network, the unit received timely and actionable information from its own sources regarding the desertation of 03 x Kuki National Front (KNF) cadres from their group along with weapons on 25 March 26. The Cadres reportedly belonged to a SoO group, and had deserted with the intention of joining non SoO group (likely UKNA)
2. Acting swiftly on the input, a column of 37 Assam Rifles was launched at 1000 Hr on 25 Mar 26 to apprehend the suspected cadres. The column swiftly moved to the general area Tuibong and commenced a well coordinated search operation. As the search progressed, the troops tactically scanned the area and identified a suspicious individual based on his movements and presence. 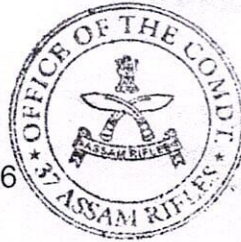
