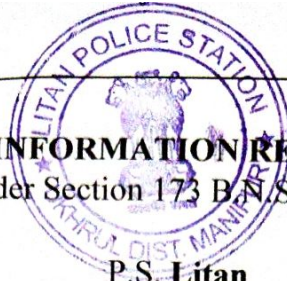

Brief of the case:

On 02/03/2026 at 7:30 pm received reliable information that on the same day at about 3:30 pm, a vehicle (ECO van) carrying some occupants of Mongkot Chepu village belonging to Kuki community, coming from the Mahadev side, and one Alto car with occupants belonging to Riha village (Tangkhul Naga community) coming from Litan side towards Mahadev side, were reportedly involved in a narrowly averted collision due to alleged wrong-side driving by the driver of the Alto car along Imphal – Ukhrul road (NH-202) near Shangkai village about 5 km south-west of Litan Police Station.
