Brief of the case:

On 11/03/2026 at about 09:00 am, received reliable information that on the same day at about 06:30 am, some youths suspected to be Tangkhul volunteers with arms came to the poppy field located at the Thawai Kuki Hill Range (Mapithel Hill Range) and destroyed the poppy plants and burnt down some of the huts in the poppy field. Further, it is also learnt that the Tangkhul volunteers fired a few rounds in the air and due to the firing, some persons who were nearby ran away from the area. On learning of the firing in the area, village volunteers of Thawai Kuki and adjoining villages also started firing and exchange of firing took place for some time. After the incident of firing, 04 (four) persons were found missing. Later on, they were identified as (i) Thangminlen Baite of Mongneljang village, (ii) Letginthang Haokip of Thawai Kuki village, (iii) Thengin Baite of Thawai Kuki village and (iv) Thangboimang Khongsai of Shangkai Kuki village. Letginthang Haokip was later found at Thawai kuki village with injuries on his body. Subsequently he was evacuated to Saikul PHC for medical treatment. After some time, Thangminlen Baite was found and rescued from Leingangching area. Search was conducted, however, the other two persons could not be found. Accordingly, a suo-motu case under FIR No. 9(3)2026/LTN-PS U/s 140/118/3(5) BNS, U/s 18(b) ND & PS Act & Us 25 (1-C) A. Act has been registered for investigation.
