Today i.e. 16/02/2026 at 10:30 am, received an information that the same day at around 10:25 am, large numbers of peoples including male and women folk numbering about 250/300 of Heirok Part-III village were assembled at Heirok Part-III Tourangbam Leikai near TLYC club and organized unruly mob by holding deadly weapons like daos, stick etc and dismantled the house of one Ningthoujam (Ongbi) Madhabi Devi 53 years W/o N. Muhindro Singh of Heirok Part-III Tourangbam Leikai and assaulted and brutally beaten up the accused person in c/w the physical sexually assaulted/rape of one minor girl. On receipt of the information, self (OC, HRK-PS) and CDO/TBL teams led by Divya, IPS, Addl. SP (L/O)/Thoubal, rushed to the spot and control the mob. Some portions of the house including household items were damaged by the said mob. The monetary value of the damaged property is about Rs. 50000/- (Fifty thousand) only. Later on, the mob has been dispersed by the police teams at 12:00 noon of the same day.
