Sir,

With due regards, I beg to state that today on 20/03/2026 at about 4:40 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Tekcham Sanji Ching for using offensive act against State Security Forces and CAPF.

On receipt of the information, joint team of Commando Unit, Thoubal led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops), Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police Thoubal and a column of 33 AR have rushed to the spot immediately and launched a massive operation at 05:20 a.m. On searching and found the undernoted articles from the spot and seized at 6:31 a.m. by observing formalities.

### Details of seized articles :-

1. 3(three) nos. of Bolt Action Single barrel bearing registration numbers (i) 0143, (ii) 0427 and (iii) 0610
2. 1(one) no. of CMG Carbine with magazine (country made) bearing registration number 1753611.
3. 1(one) no. of .32 Pistol with magazine bearing registration number P2384.
4. 1(one) no. of 9mm pistol with magazine bearing registration number 777700.
5. 3 (three) nos. of 5 56 x 45mm live round (INSAS).
6. 2(two) nos. of 5.56mm live round (M-16).
7. 8(eight) nos. of 7.62 x 51mm live round (SLR) and
8. 1(one) no. of .38 live round.

The massive searched Operation was conducted from 05:20 am to 07:00.a.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
