Sir,

With due regards, I beg to state that today on 20/03/2026 at about 6:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Tentha Marongband near crematorium for using offensive act against State Security Forces and CAPF.

On receipt of the information, joint team of Commando Unit, Thoubal under the command of Shri. H. Devendra Singh, Addl. SP(Ops), Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police Thoubal and a column of 46 AR have rushed to the spot immediately and launched a massive operation at 6:50 a.m. On searching and found the undernoted articles from the spot and seized at 07:02 a.m. by observing formalities.

Details of seized articles:-

1. 1(one) no. of .32 pistol with magazine without registration number.(Country made)
2. 1(one) no. of 9mm pistol with magazine without registration number. (Country made)
3. 2(two) nos. of Bolt Action Single barrel bearing registration number (i) XXX CK23 & (ii) 81072-23)
4. 4 (four) nos. of 5.56 x 45mm live round (INSAS).
5. 5(five) nos. of 7.62 x 51mm live round (SLR) and
6. 4(four) no. of .32 live round..

The massive searched Operation was conducted from 06:50 am to 7:30 a.m. on the same day.
