Today i.e. 23/03/2026 at 08.10 pm received a reliable information that on the same day i.e. 23/03/2026 at around 08.05 pm. one Honda Dio scooter, light grey in colour, bearing registration no. MN04H- 1275, ridden by an unknown rider, plying from Sora side towards Wangjing side was hit by an unknown Tata DI vehicle, driven by an unknown driver plying from opposite direction i.e. from Wangjing side towards Khongjom side, near Dhaka Brick Farm along NH No. 102, due to rash or negligent driving on the part of the unknown driver of Tata DI and had fled immediately after the accident. As a result of the impact, both the rider and the pillion rider of the Honda Dio sustained serious injuries on their persons and evacuated to the hospital for necessary medical treatment.

Hence a suo-moto case under FIR No. 08(03)2026 KJM-PS U/s- 281/125(b)-BNS, 2023 and 134/187 MV Act 1988 has been registered for investigation.
