**12. First Information contents:**



Today i.e. 23/03/2026 at 09.30 pm received a reliable information that on the same day i.e. 23/03/2026 at around 09.10 pm. one Honda Activa 6G scooter, red in colour, bearing registration no. MN06SF- 2845, ridden by an unknown rider, plying from Tentha Khunjao side towards Tentha Khongbal side collided with another TVS Ntorq scooter, black in colour with yellow stripes, bearing registration no. MN01AO-6012, ridden by an unknown rider plying from opposite direction i.e. from Tentha Khongbal side towards Tentha Khunjao side, near Tentha KPES School along the IVR of Wangjing Tentha, due to rash or negligent driving on the parts of both the unknown riders of both the vehicles. As a result of the impact, the unknown rider of Honda Activa 6G scooter, red in colour, bearing registration no. MN06SF-2845 sustained serious injuries on his persons and evacuated to District Hospital, Thoubal, for necessary medical treatment, however the doctor on duty declared to be brought death. Both the vehicles involved in the incident were also badly damaged.

Hence a suo-moto case under FIR No. 09(03)2026 KJM-PS U/s- 281/125(b)/106(1) BNS, 2023, has been registered for investigation.
