Today, i.e 19/03/2026 at 1:30 pm received an information that on the same day at around 1:25 pm, one Motorcycle pulsar Black in colour bearing Regn. No. MN01A- N5877 ridden by an unknown rider coming from Yairipok Bazar side towards Khoirom side met an accident with a Tractor red in colour bearing Regn. No. MN04/9774 driven by unknown driver which was coming from opposite direction at Yairipok Khoirom near Khoirom Play Ground along Yairipok Khoirom road due to rash or negligent driving on the part of both rider and driver of the above vehicles. Due to impact of accident the unknown motorist sustained injuries on his person and evacuated to the Hospital for medical treatment and Motorcycle pulsar was also party damaged.
