Today i.e. 11/04/2026 at 02.45 pm received an information that on the same day at around 02.40 pm one Bolero, white in colour, bearing registration No. MN06LX 3645, plying from Wangjing side towards Khongjom side driven by unknown driver, dashed on the right side of one Honda Activa red in colour bearing registration No. MN01V 7721 travelling through same direction, ridden by unknown rider due to rash or negligent driving on the part of the unknown driver of the Bolero near the Samaram Lamkhai along NH No. 102. As a result of which the unknown rider of Honda Activa red in colour bearing registration No. MN01V 7721, sustained injuries on her person and evacuated to District Hospital Thoubal, for medical treatment and both the involved vehicles are also partly damaged.
