12. First Information contents:

Today i.e. 14/04/2025 at around 09.42 pm Khongjom Police Station received a communication from the Control Room, District Headquarters, Thoubal regarding a Tata 407 HT Truck light maroon in colour bearing registration number MN05C - 4079, carrying a load gravel stone, which was reportedly being driven by unknown driver in a rash and negligent manner from Wangjing side towards Sora Side via Khongjom, thereby posing danger to the public and other road users with attempt to hit the other vehicles plying on the NH-102 .

Acting upon the said information, a Naka/barricade was set up by police personnel on the highway NH-102 in front of Khongjom Police Station to intercept the said vehicle. Despite visible police presence and barricading of the road, the unknown driver of the said vehicle did not stop and instead rammed through the barricades at 09.55 pm and proceeded towards Sora side, causing damage to government property and endangering the lives of on-duty police personnel and fled away from the spot.

Subsequently, the Police teams of Khongjom, Thoubal, Yaripok along with G-39, G-42 CDO team initiated a chase, and the said vehicle along with the unknown driver was successfully intercepted at Sora Mayai Leikai at 10.30 pm, falling under the jurisdiction of Kakching Police Station. During the process of detention, local persons gathered at the spot and attempted to form an unlawful assembly, obstructed police personnel in discharge of their lawful duties and attempted to create a mob-like situation. Hence, the said Tata 407 HT Truck could not be recovered at the spot i.e. Sora Mayai Leikai and left there itself. Later, after hectic effort the accused driver was detained and then brought to Khongjom Police Station for further legal action.

Hence, a regular *Suo-Moto* case was registered under FIR No 12(04)2026 KJM-PS u/s 125/221/223/281/324/351 BNS 2023 and 132/179/184 MV Act of 1988.
