Today, i.e 28/03/2026 at 7:20 am received an information that on the same day at around 7:10 am, one Honda Dio Black in colour bearing Regn. No. MN01AR- 2403 ridden by an unknown rider coming from Yairipok Bazar side towards Heitroipokpi side collided with a Tata Truck blue in colour bearing Regn. No. MN03T/1608 driven by unknown driver which was coming from same direction at Yairipok Heitroipokpi near Tata Workshop along Yairipok Kasom road due to rash or negligent driving on the part of both rider and driver of the above vehicles. Due to impact of accident the unknown Honda Dio rider and pillion rider sustained injuries on their persons and evacuated to the Hospital for medical treatment and Honda Dio was also party damaged.

Hence a suo motu case under FIR No. 13(03)2026 YPK- PS u/s 281/125(b)/324(4) BNS, 2023 has been registered for investigation.


