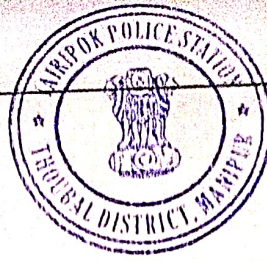

First Information contents: On 14.04.2026 from 5:30 pm, I along with police team of Yairipok-PS were discharging law and order duty at Yairipok bazaar. Curfew was imposed by the District Magistrate, Thoubal District vide order No. 4/65/DC(TBL)/L&O/2026 dtd 08.04.2026 until further orders. The DM/Thoubal relaxed the period of imposing curfew from 5:00 am to 5:00 pm on 14.04.2026 vide order No. 4/65/DC(TBL)/L&O/2026 dtd 13.04.2026. After 5:00 pm, curfew was throughout the area covered by the Thoubal district.



While I and my police team were on duty at Yairipok bazaar junction, one 407 Tata-Truck bearing No. MN-05C/4079 was coming from Yairipok khoirom side towards yairipok via Thoubal road at about 9:00 pm. I and my police team gave signal to stop the said 407 Tata-Truck as it was coming violating the curfew imposed. The unknown driver of the Truck, inspite of stopping and respecting the police personnel on duty while discharging lawful duty, forcibly drove the said Tata-Truck even to kill anyone physically for obstructing the movement of the Truck. In that situation, I and my police team chased the said Tata-truck and the said Truck gave no way to overtake and partly damaged on the front part of police gypsy while trying overtake. Being suspected the manner and nature of the unknown driver of the truck, I informed to the Police control room of Thoubal district police to stop the said vehicle by any police on duty. While I followed the said Truck a police team of Thoubal-PS attempted to stop the said Truck at near Tomching Toll-tax drop gate. There also the driver of the said Truck without caring the signal to stop, drove ahead by breaking the said drop gate.

My team along with TBL-PS teams who were at the said check gate chased the said truck. The said Truck driver drove ahead towards Wangjing side on NH-102 by dashing against the Barred gates in front of TBL-PS gate and the office gate of DHQ/SP-TBL. The control room was informed of the development and the control informed khongjom-PS to stop the said 407 Tata-Truck which was heading towards khongjom side. In the meantime 2 CDO teams of Thoubal District joined the chased the said Tata-Truck. When at Khongjom-PS gate also, the police team of KJM-PS made their best attempt the stop the said Truck. The unknown driver of the truck forcibly drove thereby pushing all the barred gates and successfully escaped towards Sora side along NH-102. The police team of KJM-PS also joined the chased. The Truck did not give space to overtake.

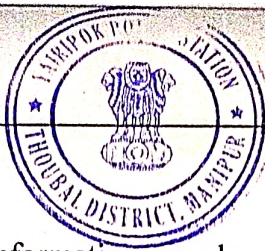
While reaching Sora Bazaar, the said truck took left turn through IVR of Sora Mamang Leikai from the main road. We still kept on chasing. After chasing about 2 Kms the said Truck slit the right side wheel in the roadside nala (drain). The driver made his best attempt to drive out of the said nala. All the police teams chasing the said Truck, arrived at the said spot and kept cordoned.

The said unknown driver was arrested and taken by the teams of khongjom-PS. No handyman was in the said Truck. The Truck can't be taken from there as the right side rear wheel were in the nala.

While I and my police team came out from the said spot of Sora mamang Leikai, a huge numbers of the inhabitants of the local came out and attacked my police team and caused damaged to the gypsy vehicle of Yairipok-PS which I and my team used at the time and place. It is at about 11:30-12:00 pm as the number of the persons attacking were very high and there was the probability increasing their numbers. I and my party did not resolve to any action against them for that a separate complaint is being file to the OC/kakching-PS as the P.O is within kakching district and within the PS jurisdiction of Kakching-PS.

The aforesaid act of the TataTruck-407 driver namely Md. Tajuddin @ Harun aged about (41 Yrs) s/o (L) MV. Yasin of Yairipok Bamon Leikai amounts to violation of the curfew, imposed by the DM/Thoubal district, disobedience the lawful order of the public servant and causing an attempt to commit murder of the police personnel on duty by rash and negligence driving and caused damaging the public property..

Hence a suo motu case under FIR No. 17(04)2026 YPK-PS u/s 109/223/221/125/281 BNS, 2023 and Sec.3 Damage to public property Act,1984 is registered against the driver of the Truck.


