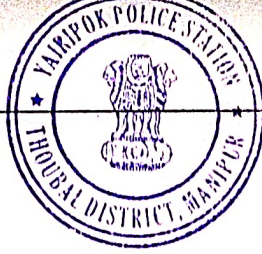

7. First Information contents:

Today, i.e 17/04/2026 at 4.40 pm, received an information that on the same day at about 4.30 pm one Honda Activa bearing Reg. number not known ridden by an unknown girl with two girls pillon ridders which was coming from Yairipok side towards Thoubal side. It was hit, on the right side handle by the side mirror of a white Maruti car, white in colour, Reg. number not known which was coming from the opposite direction at Phouden near Nganu Lampak along Yairipok Thoubal road due to rash or negligent driving on the part of the unknown driver of the car.

Due to impact of the hit the ridder of the Honda Activa and two pillion ridders fell on the road along with the Honda Activa.

As a result of which, the ridder of the Honda Activa received serious bleeding injury on her head while other two pillion ridder received minor injuries on their persons.

However the unknown car fled away from the spot without rendering any assistance to the injuries after commission of the offence.

Hence a suo motu case under FIR No. 19(04)2026 YPK- PS u/s 281/125(b) BNS, 2023 has been registered for investigation.




