Today i.e. 27/02/2026 at @ 06:05 pm, teams of NCB Imphal & CDO Imphal West led by Addl. SP(ops) Imphal West requested to assist their team in raiding the house of one accused person namely Md. Sabir Ahamed aged about (26) S/o Md. Abdul Gaffar of Lilong Yangbi Leikai to arrest him in c/w NCB Imphal crime no. 04/2026. Accordingly self along with teams of Lilong PS including women Police personnel and the teams of NCB Inphal & CDO Imphal West rushed at the house of Md. Sabir Ahamed at around 06:30 pm. The said accused person namely Md. Sabir Ahamed was found near his house and detained him. Thereafter the combined team searched his house. When our team was about to leave his house with the accused person Md. Sabir Ahamed, family members of Md. Sabir Ahamed alarmed the nearby people and at a sudden, some unknown persons numbering about 200/250 comprising of both male and female were assembled and formed an unruly mob. The unruly mob overpowered our team and stormed towards us. The unruly mob didn't hear what our team requested and snatched Md. Sabir Ahamed forcibly. The unruly mob even tried to snatch arms from our team



and helped the accused person namely Md. Sabir Ahamed to flee away from there at an unknown direction. Self-have warned the unruly mob to disperse but to no heed. At around 11:10 pm, the re-enforcement teams and Executive Magistrate arrived there and warned the unruly mob to disperse. As the unruly mob didn't disperse after giving ample warning, the mob was dispersed by using minimal force at around 11:30 pm. While dispersing the unruly mob, one Abas Ali @ Ziau Rahaman of Lilong Yangbi Leikai who was among the unruly mob was arrested from the spot at 11:32 pm of 27/02/2026. As there was an unruly mob, procedure U/S 105 BNSS could not be observed.
