

First Information contents: Today i.e. 15-02-2026 at 8:05 pm received information that on the same day at around 8:00 pm, a road traffic accident occurred along NH 102 at Thoubal Melaground in between one Grand Vitara bearing registration No. MN01CS0518 driven by an unknown driver coming from Imphal side towards Wangjing side and one I20 car bearing registration No. ML05P 5455 driven by an unknown driver while the I20 car was passing the road towards Yairipok side, due to rash or negligent driving on the part of the both unknown drivers. As a result, the driver of the grand vitara and some occupants of the both vehicles were sustained injuries and evacuated to Hospital for giving medical treatment. Both the vehicles were also badly damaged.
