

First Information contents: Today i.e. 16/02/2026 at 7.40 am, received information that on the same day at about 7.30 am, one Swift car bearing registration No. DL9CAB5861 driven by an unknown driver coming from Thoubal side towards Imphal side dashed into one Honda Activa bearing registration No. MN01AH3828 ridden by an unknown rider coming from same direction along NH 102 in front of Babu Bazar due to rash or negligent driving on the part of the unknown driver of swift car. As result, both the driver and rider including one pillion rider and two occupants sustained injuries and evacuated to Hospital for medical treatment. Both the vehicles were also badly damaged.
