Subject: Complaint against Md. Jamil (58) @ Taher Ali Shah S/O Md. Jeinul Abadin of Golapati Maning Leikai PO/PS- Porompat, Imphal East and Nongsaibam Sanjit (35) S/O Late N. Yaima of Yairipok

Tulihal Toubokpi, PS- Andro, Imphal East for cheating, Criminal Breach of Trust, criminal conspiracy, false allegations and illegal occupation of land

Sir,

I, Md. Askar, S/o- (L) Alhaj Mv Helaluddin, R/o- Lilong Chaobok Mairenkhun, PO/PS-Lilong, do hereby respectfully submit this complaint for your kind consideration and necessary legal action.

1. That I purchased a plot of land situated at Hatta Golapti through Nongsaibam Sanjit from Md. Jamil of Golapati Maning Leikai for a total consideration amount of Rs.50,00,000/- (Rupees Fifty Lakhs only), which was duly paid by executing a Mortgage Deed at my place. The transaction was genuine and executed on mutual understanding between the buyer and seller.
2. That after the said purchase, Md. Jamil has illegally and forcefully continued to occupy the said land. Upon confrontation, he assured that he would pay a sum of Rs.100000/- (One Lakh only) per month as rent fee for such occupation.
3. That Md. Jamil has failed to pay the promised rent amount since the year 2022, thereby causing wrongful loss to me.
4. That upon further enquiry, Md. Jamil falsely stated that he had already paid the said amount to Nongsaibam Sanjit, which is incorrect and appears to be a deliberate attempt to mislead and committing criminal breach of trust.
5. That now both Md. Jamil and Nongsaibam Sanjit, in collusion with each other, have started making false claims and have initiated civil proceedings alleging that the sale deed is false, whereas the transaction was genuine. The execution of the document as a gift deed was done on mutual understanding and is now being misrepresented with dishonest intention committing criminal breach of trust.
6. That in fact, on 19/03/2026 Nongsaibam Sanjit and his brother Nongsaibam Feroj had come voluntarily to my residence only for discussion and settlement of the matter including repayment of the land purchase amount or handing over of the land.
7. That, in furtherance of their conspiracy, Md. Sanjit has lodged a false complaint at Lilong Police Station alleging that Md. Sanjit was kidnapped by me along with my elder brother Md. Sagir Ahamed, which is entirely false, baseless, and malicious. Accordingly the Officer-in-Charge of Lilong Police Station registered an FIR against me and my brother Md. Sagir Ahamed.
8. That the FIR registered against us is completely malafide, motivated, and an abuse of the legal process and the same deserves to be disposed of/closed after proper enquiry.
9. That the concerned land record officials are ready and willing to give statements confirming that the land transaction amounting to Rs. 50,00,000/- (Rupees Fifty Lakhs only) is genuine and lawful.

In view of the above facts and circumstances, it is therefore most humbly prayed that:

- A proper and fair enquiry may kindly be conducted into the matter.
- Necessary legal action may be taken against Md. Jamil and Nongsaibam Sanjit for cheating, Criminal Breach of Trust, criminal conspiracy and filing false allegations.
- The false FIR registered against the undersigned may kindly be reviewed and disposed of in the interest of justice.
