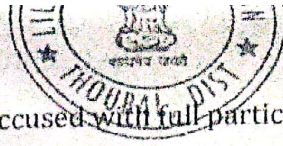

I have the honour to report that today i.e. 01/04/2026 at about 06:15 p.m. received a reliable information that some vehicle lifter were loitering in and around Lilong Turel Ahanbi area. On receive of the information, a joint team of Commando Unit Thoubal comprising of Golf-57, Golf-97 & Golf-93 led by Shri K. Nitaranjan Singh Office-in-charge, Commando Unit Thoubal under the supervision of Shri. Hijam Devendra Singh, MPS, Addl. Superintendent of Police (Ops) Thoubal and under the overall supervision of Shri. 

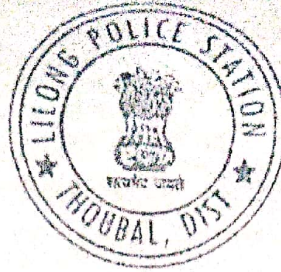
