I have the honour to state that on 02/04/2026, one Md. Abdul Kalam (45) S/O Md. Abdul Hekim of Lilong Dam Makha Zable Rahmania Ching reported to OC/LIL-PS stating that 29/03/2026 at about 8:30 am, his son namely Md. Saruk Khan (16) S/O Md. Abdul Kalam of Lilong Dam Makha Zable Rahmania Ching, PO/PS- Lilong, Thoubal District Manipur left from the residence of his grandmother namely Mrs. Hajibi Ijan Bibi W/O Md. Kalamuddin of Lilong Atoukhong Mamang Leikai for his residence and did not return back till date in spite of vigorous search. He can speak Hindi, English and Manipuri only. Physical description of his son- Height-5.5 ft, fair, Face-oval, black & short hair, slim body and his wearing appearance-One kurta white in colour and a pair of slipper blue in colour and one black in colour.

In this regard, OC/LIL-PS made a GD entry vide GD No. 12/LIL-PS/2026 dated 02/04/2026 for enquiry and endorsed the same to me for proper enquiry.

Accordingly self-have made a concrete enquiry into the matter. During the course of enquiry, examined the complainant and his relatives including Grandmother minutely in the case. From the enquiry, it reveals that Md. Saruk Khan (16) had left the house of his grandmother namely Mrs. Hajibi Ijan Bibi W/O Md.
