I have the honour to report that on 23/2/2026 at about 8:30 am, my mother Thoudam Premabati Devi 55 years w/o Th. Joychandra Singh of Thoudam Irong Thokchom who went to Leishangthem on a bicycle was knocked down by one scooter Honda DIO bearing regn. no. MN01AM7238 being ridden by Md. Ayub Ali 47 yrs s/o late Md. Janab Ali of Irong Khunou from the back and it was occurred at Thoudam Bazar along Mayang Imphal Road due to rash or negligent riding on the part of the said Honda DIO rider. As a result, my mother sustained severe multiple injuries and taken to the District Hospital, Thoubal. At present, she is undergoing treatment at RIMS, Lamphel. I could not report in time while attending hospital.

It is therefore, requested to take up necessary legal proceedings in this regard.
