Sir,

I have the honour to report that, on 26/02/2026 at around 2.30 pm, my Scooter Honda Activa 6G DLX, rebel red metallic 2 in colour, b/regn.no. MN01AM8882, Ch/No. ME4JF91AGNG305579, Eng/No. JF91EG7306069 which was registered in the name of Safia Bibi W/o Md. Abdul Majid of Sangaiyumpham, Nungphou Mamang Leikai, Thoubal was found stolen away by unknown person while kept parked under proper locked at Wangbal Canal, Thoubal. The value of the said stolen Scooter is worth about Rs. 90,000/- only and was unable to locate till date upon various searches.
