Subject: Complaint regarding theft of truck batteries and rice bags.

Sir,

I would like to lodge a complaint regarding a theft that occurred at my stone crusher factory located at Thoubal Haokha.

In the early morning at around 2:00 am of 12/03/2026 unknown persons entered the premises of my factory and committed theft. Two trucks were parked inside the compound, and the two batteries (12,000 x 2 = 24,000) from both trucks were stolen. In addition to this, two rice bags (1400 x 2 = 2,800) stored in the factory premises were also taken by the miscreant.

The incident came to our notice the following morning when we inspected the vehicles and the factory premises. We also have CCTV footage from the factory which captured the incident and may help in identifying the persons involved.

This incident has caused financial loss and concern regarding the security of the premises. Therefore, I kindly request you to register this complaint and take necessary action to investigate the matter identify the culprits, and recover the stolen items.

I shall be ready to provide the CCTV footage and any further information required for the investigation.
