Today i.e. 18/03/2026 at 6.20 pm, received information that on the same day at @ 6.10 pm, one Tata truck bearing registration number MN019023 and driven by an unknown driver while coming from Thoubal towards Khongjom side, knocked down one Honda Activa bearing registration No. MN04G0942, which was proceeding in the same direction, due to rash and negligent driving on the part of the Tata truck driver along NH 102 at Wangjing Khabakhong opposite to tall tax. As a result, the rider and one pillion rider sustained injuries. Another pillion rider succumbed to injuries at the spot due to severe impact. The driver of the Tata truck fled away from the spot along with the vehicle. The Honda Activa damaged partly in the incident.

Hence, a suo-motu case under FIR No. 56(3)2026 TBL-PS u/s 281/125(a)/324(4)/106(1) BNS has been registered for investigation.
