
Today i.e 23/03/2026 at 4:37 pm, received information that on the same day at around 4.25 pm, one Tata Dipper bearing regn. No.ASO1BS1438 driven by unknown driver while coming from Heirok towards Wangjing Bazar side knocked down one Honda Activa bearing regn. No.MN01Z9888 ridden by unknown rider which was proceeding in the opposite direction due to rash & negligent driving on the part of the driver of the Tata Dipper at Wangjing Awang Leikai in front of Pork Centre of Ningthoujam Nando Singh, 55yrs S/o N. Tamar Singh along IVR of Wangjing Heirok road. As a result of it, the rider and the pillion rider sustained severe injuries on their persons and evacuated to District Hospital Thoubal. However, the pillion rider was declared brought dead by the doctor on duty. The Tata Truck was partly damaged and the Honda Activa was badly damaged. Hence the case.
