Today i.e 26/03/2026 at 9:10 pm, received information that on the same day at around 8.50 pm, a road traffic accident occurred at Wangjing Lamding near Romesh Service Station (Oil Pump) along NH-102, Thoubal involving one Scooter TVS Jupiter 125 b/reg.n.no. MN01AR7471 ridden by an unknown rider and one unknown car where both vehicles were heading towards Thoubal from Khongjom side, due to rash & negligent driving on both rider of Scooter TVS Jupiter 125 b/reg.n.no. MN01AR7471 and driver of unknown car. In the said incident, the unknown car fled away from the spot immediately after the accident. As a result of it, the rider of Scooter TVS Jupiter 125 b/reg.n.no. MN01AR7471 sustained injuries and evacuated to District Hospital Thoubal. The said Scooter TVS Jupiter 125 b/reg.n.no. MN01AR7471 was also damaged. Hence the case.
