I have the honour to report that, in the midnight between 3/04/2026 at around 11.30 pm and 4/4/2026 at around 12.10 am, my Scooter Honda Activa DLX bearing regn.no. MN06SK5102, Rebel Red Metallic-2 in colour, Chassis no. ME4JK156CRW566392, Engine no. JK15EW5566144 & Model-2024 which was also registered in my name was found stolen away by unknown person while it was parked under proper locked at the Courtyard of one Thoudam Robita Devi W/o (L) Th.
