Dear Sir,

I would like to inform you for your kind consideration that an incident of attempted theft of HSD (High-Speed Diesel) has occurred at our project area, Waithou Pat Waterbody, located at Waithou Pat Water Supply Plant.

On 08.04.2026 at around 09:30 PM, an unidentified person unlawfully entered the project premises and attempted to steal HSD. During the incident, the accused fled from the scene, leaving behind a mobile phone and a key. These items are currently in our custody and can be handed over as evidence to assist in the investigation.

Although no material was ultimately stolen, the incident poses a serious threat to the safety and security of our project site and the workers residing there.

In view of the above, I humbly request you to kindly register this complaint/FIR and take necessary action to investigate the matter, identify and apprehend the accused at the earliest.
